Dear Valued Customer,

The shelf life of the *Status*TM COVID-19/Flu A&B test kit ("product") was initially established as 6 months due to the rapid and recent development of the product and according to regulatory requirements. PBM has continued to conduct real-time stability testing to extend the expiration date. The product in your possession may now have an expiration date that is later than the labeled date.
