This communication contains important information concerning changes to the Intended Use Statement (i.e., For Forensic Use Only), new electronic Instructions for Use, and labeling change for the BD Vacutainer[®] Blood Alcohol Determinations Tube (Sodium Fluoride 100mg, Potassium Oxalate 20mg).

On September 1, 2023, BD Life Sciences will begin implementing the product labeling changes listed below for the BD Vacutainer® Blood Alcohol Determinations Tube.

Changes to Instructions for Use

The Instructions for Use has been updated. Key updates include the following:

Intended Use Statement Change - The BD Vacutainer® Blood Alcohol Determinations Tube will now be labeled as "For Forensic Use Only." The updated intended use will read:

The BD Vacutainer[®] Blood Alcohol Determinations Tube is an evacuated, sterile, single-use product intended for the collection of venous blood for testing of blood alcohol for the purposes of law enforcement. For Forensic Use Only.

Precautions - The following precaution has been added:

The BD Vacutainer[®] Blood Alcohol Determinations Tube contains compounds that can leach or outgas into blood specimens that may potentially interfere with chromatographic methods. Laboratories should conduct appropriate validations of chromatography-based assays to ensure these compounds do not interfere.¹

Fill Indicator – A fill indicator has been added to the tube label, and is described in the Instructions for Use.
