## Section 4 First aid measures

**INGESTION:** Call physician or Poison Control Center immediately. Induce vomiting only if advised by appropriate medical personnel. Never give anything by mouth to an unconscious person.

**INHALATION:** Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.

**EYE CONTACT:** Check for and remove contact lenses. Flush thoroughly with water for at least 15 minutes, lifting upper and lower eyelids occasionally. Get immediate medical attention.

## Section 5 Fire fighting measures

**Suitable Extinguishing Media:** Carbon dioxide, dry chemical, dry sand, alcohol foam.

**Protective Actions for Fire-fighters:** In fire conditions, wear a NIOSH/MSHA-approved self-contained breathing apparatus and full protective gear. Use water spray to keep fire-exposed containers cool.

**Specific Hazards:** During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Dust dispersed in air becomes explosive when exposed to ignition sources.

## Section 6 Accidental release measures

**Personal Precautions:** Evacuate personnel to safe area. Use proper personal protective equipment as indicated in Section 8. Provide adequate ventilation.

**Environmental Precautions:** Avoid runoff into storm sewers and ditches which lead to waterways.

Avoid contact with eyes, skin and clothing. Do not inhale dusts. Use with adequate ventilation. Avoid ingestion. Wash thoroughly after handling. Remove and wash clothing before reuse.
